### **Eritrea-Ethiopia Claims Commission (EECC): Partial Awards**

*The EECC issued two awards addressing both Eritrea and Ethiopia's claims for losses, damage and injury suffered as a result of violations of international law occurring following the outbreak of hostilities on the Central Front during the 1998-2000 international armed conflict between Eritrea and Ethiopia.*

### **ICTY: Prosecutor v. Radislav Krstic**

*The Appeals Chamber reduced Krstic's sentence by eleven years, finding, inter alia, that his criminal liability constituted "aiding and abetting genocide" under Article 7(1) of the Tribunal's statute, rather than "complicity in genocide" under Article 4(3)(e) as determined by the Trial Chamber.*

### **United States Supreme Court: Sosa v. Alvarez-Machain**

*The U.S. Supreme Court held that the Alien Tort Claims Act is a jurisdictional statute creating no new causes of action, and denied Alvarez-Machain's claim for damages.*

### **United States Supreme Court: Republic of Austria v. Maria V. Altmann**

*The U.S. Supreme Court concluded that the Foreign Sovereign Immunities Act applies to conduct that occurred prior to the Act's 1976 enactment and prior to the United States' adoption of the "restrictive theory" of sovereign immunity.*

### **U.N. Security Council: Resolution 1546 (The Situation Between Iraq and Kuwait)**

*Acting under Chapter VII of the Charter of the United Nations, the Security Council endorsed the formation of a sovereign Interim Government of Iraq.*
